
- Student must meet the entering GPA for the term. CSU
 Fullerton is impacted at the local level as well as major
 impacted. The cumulative GPA of a verified SB 1440 applicant
 will be increased by 0.1 and this 'calculated GPA' will be
 applied to the major specific minimum GPA and to any GPA
 used in the ranking of applicants.
- Student must be in good standing at the last college or university attended (eligible to re-enroll).
- Student must have earned 60 or more transferable semester units (90 or more quarter units).
- Students must complete the Golden Four courses by the term deadline.
 - Fall deadline: no later than the end of the Spring term.
 - Spring deadline: no later than the end of the Summer term.

Identification Process

Proof of a ADT in-progress or completed can be sent to CSU Fullerton by regular mail or electronically.

- Verification forms of the Transfer Degree are mailed to us from the community colleges. Verification forms vary college to college.
- Students can also email us verification forms or graduation forms to us at transferdegree@fullerton.edu
- Electronic transcripts containing information on the Transfer Degree are electronically sent to us from various sources, e-Transcript CA, Credentials, etc...





 - Saved as TIFF images for easier reading
 - PeopleSoft/CMS
 - Education pages marked as received next business day
 - Based on extract of transcripts from FileNET
 - SQR process performs the work

Reading the EDI

- Custom Developed Program
 - C# program developed using Visual Studio 2010
 - Windows GUI or command line for scheduled runs
 - Comprehensive log files of work performed
 - Multi-format support
 - AnyDOC OCR
 - TS130 (Texas SPEEDE + Etran)
 - SMTP support for emailing alerts
 - Outputs text/image files of data formatted for easy reading

Daily Process

- 1. EDI files download via XAP and/or Texas SPEEDE
- 2. Files moved to queue folder
- 3. C# process runs
 - Search/match against CMS list of students
 - Coursework loaded into DARWIN
 - Text/image file created of extracted data
 - SB1440 alerts sent if degree encountered

Student Groups

- Student Groups have been created in our PeopleSoft system to manage, track and monitor ADT applicants and students.
- We have created five Student Groups:
 - Self-Identified on Application: TRDS
 - 2. In-Progress SB1440 Verification Form/Transcript: TRDG
 - Verified SB1440 Completed: TRDV
 - 4. Incomplete SB1440: TRDN
 - 5. Cancelled SB1440 Agreement: TRDC
- Students will most likely be in more than one Student Group.

Titan Degree Audit (TDA)

- In-Progress ADT Verification Form/Transcript Received: TRDG
- Verified ADT Completed: TRDV
- Incomplete ADT: TRDN
- Cancelled ADT Agreement: TRDC
 - TDA has been updated to use and display four of the Student Groups.
 - If students coded as TRDG or TRDV, lower division course requirements are waived on their TDA. If the degree is not earned (TRDN) or cancelled (TRDC), their TDA is updated.
 - ADT Degree Code (example 31976) information has been added to the Education page in PeopleSoft for the community college.

ADT Reports

Transcript Summary Report

- Using our Custom EDI process, we identify all electronic transcripts received by college and source (eTran, Credentials, Docufide, SPEEDE)
- It also outputs a listing of all ADT transcripts received.
- Report sent out electronically daily

ADT Summary Report

- SQR report in PeopleSoft.
- Gather info from Student Groups and/or education pages.
- Outputs several different report views
 - Term Overview
 - Application Status
 - By Academic Plan
 - By Community College
 - Outputs list of students (in valid majors and invalid majors for their ADT)
- Provides critical statistics by term.
- Helpful for monitoring and planning purposes.

Automatic Communications

- Developed a systematic and automated way to communicate.
- Students need to be informed of what the ADT degree provides them in the way of admissions and progress towards their degree at CSU Fullerton.
- Runs based on inclusion in Student Groups.
- Messages are emailed to student and archived in Imaging.
- Eliminates need to run queries and manually email students.
- Emails are triggered every time a student is added to a specific Student Group (TRDS, TRDG, TRDV, TRDN or TRNC).
- Emails inform students of their current status and provides detailed information about their status.
- Communications Mod was launched in January 2014.

If you are admitted to CSU Fullerton and we do not receive verification of your degree awarded by the deadline, you will not receive the benefits of the transfer degree and may need to retake some of your lower division coursework.

Cancellation Process


- When ADT admitted students deviate from the plan (add minor, change major, DQ, etc.) it cancels the agreement.
- Prior to this Mode, Records staff needed to monitor all plan adjustments.
- Developed a process that runs daily and automatically adds students to "Cancelled" group as needed.
- Staff automatically notified daily when any students are cancelled to verify results.
- Communications are emailed to the student.
- All communications are imaged.
- Titan Degree Audit (TDA) is updated to reflect change.
- Cancellation Process was launched in February 2014.

Future Mods: Automatic Student Group Coding

- Based on EDI processed daily, we will generate logs that can be import into PeopleSoft.
- PeopleSoft process will automatically code students in TRDG (In-Progress) or TRDV (Verified) based on files.
- Will eliminate a lot of manual work.
- Processing planned for development later this year.

Future Mods: Advising Holds

- With the different requirements of ADT students, there is a need for special advising for these students.
- New processing being developed will place different advising holds for students in the same major depending upon if they are an ADT student or not.
- CSUF College of Business will be the first College to use the new advising holds.
- Using the Student Groups an automated process is being developed to place the different advising holds for (aka service indicators) for their ADT students.
- PeopleSoft process will automatically place these holds once students are matriculated.
