SB1440 Overview

- SB 1440 signed into legislation in 2010
- Implementation and Oversight Committee (IOC) formed with CCC and CSU representatives
- Intersegmental sub-committee of IOC formed to look at automation
- Implemented placeholders in EDI TS130 Transcript file to support AD-T
 - Placeholders are not yet widely used

Current Verification Process


- CSU Mentor AD-T responses are downloaded, scrubbed, parsed into 112 files, and placed on Secure FTP site for pickup by colleges
- Students must submit verification of AD-T to each CSU
 - Each of the 23 campuses may have their own process
- Used by CSU campus admission staffs to inform in the priority SB 1440 admission decisions
- CC Deadline March 15th, CSU Deadline April 1st




Pilot Project (AD-T eVerify)

- SDSU, working with local community colleges, built a web-based AD-T verification application
 - Allows colleges to verify the AD-T
 - Student does not need to submit paperwork to SDSU
- Intersegmental sub-committee of IOC reviewed the application and endorsed a pilot for a state-wide version
- CSU is currently working on the pilot
