### Getting Started Trading Transcripts -

#### Panel Discussion for New Users ROOM 202

**At a Glance:** Panel Discussion for New Users

**Description:** Experienced trading partners from both 2 and 4 year institutions will discuss the challenges, how they resolved problems, and help answer questions from new and prospective users about trading transcripts. Transcript vendors are invited to join the meeting as audience members to provide clarity and insight during discussions.

### Transfer Students: Associate Degree for Transfer and e-Verify ROOM 106: 10:10am-12:20pm

**At a Glance:** Panel Discussion on Transfer Degrees from both the CCC and CSU prospective and a demonstration of new e-Verify site

**Description:** The session is designed as a panel discussion and consists of CCC and CSU staff members that identify, process and work with students with ADT degrees. The session will focus on how ADT degrees are not only technically processed, but also the business process of identifying and handling them from both the sending and receiving institutions' prospective. Topics that will be covered include ADT eTranscript processing, identification of ADT students, student communication from the CCCs and CSUs, redirection of denied ADT students, CCC advising, CSU admission processing including admission/GPA ranking and more. The session will also include a demonstration of the new e-Verify site and a discussion on how CCCs and the CSUs are using the new site. This is a great opportunity for CSU and CCC staff to communicate directly regarding the end to end process of ADT degrees. It is also an opportunity to share best practices to improve and facilitate the processing of the prospective ADT students' applications.
