Components of Certification Data

What is needed and what do the symbols mean?

- Data needs to be entered for the CSU GE, CSU IGETC, AND the UC IGETC
- Date that each requirement was completed
- Symbols for completion:
 - **“Y”** = Certified completed by the institution sending the transcript
 - **“N”** = Indicating that the work is not completed
 - **“P”** = Indicating the sending institution is using applicable transferred coursework that meets the criteria for the area. Essentially, the symbol **“P”** = **“Y”**.
